Sub: 14th Junior and Sub-Junior National Para Athletics Championships 2025.

Greetings from the Paralympic Committee of India.

We are pleased to inform you that the **14th Junior and Sub-Junior National Para Athletics Championships 2025** will be held from 29th to 31st August 2025 at **Atal Bihari Vajpayee Training Centre for Disability Sports**, Gwalior, Madhya Pradesh. The Championship is organised by the **Paralympic Committee of India** along with the **Ministry of Social Justice and Empowerment, Government of India**.

This Championship will serve as a probable selection platform for the National coaching camp for the upcoming Asian Youth Para Games 2025, Dubai.

The Age limit for the Athletes for the aforementioned National Championships is as per the Asian Paralympic Committee cutoff and is as follows:

- 1) Junior – U20 Boys & Girls:** born between **01. 01. 2006 – 31.12.2008**
- 2) Sub Junior - U17 Boys & Girls:** born between **01. 01. 2009 – 31. 12. 2011**

All the Affiliated State units are advised to go through this circular carefully and send the entry forms accordingly.

Note: The last date to submit entries is **20th August 2025**.

Classification: 29th August 2025, **Classification is conducted only for New Athletes.**

Competition dates: 30th & 31th August 2025

Departure of the Teams/Para Athletes: 31st August 2025 (Evening) & 01th September 2025 (Morning).

Entry:

All the entries are to be routed through the affiliated state units only to the mentioned link, and any individual athlete's entry will not be accepted.

- An Athlete can participate in a maximum of three individual events.
- Only two entries per event per state are allowed.
- International classified Confirm/Review Para Athletes will only be allowed to participate in the same sports class, and classification is not necessary during the championship.

- **Last Date for submitting the entries is 20th AUGUST 2025**

Classification:

- Only for New Athletes Classification process will be conducted.
- For International Classified Para Athletes, classification is not necessary.
- Athletes who have participated in the previous National Championships, IBSA National Championships & SIVAS India National Championships are also eligible.
- For Athletes who have participated in the 13th Junior and Sub-Junior National Para Athletics Championship 2025 and the 23rd National Para Athletics Championships 2025, classification is not necessary.
- If necessary, the International Para-Athletes or Athletes who participated in the nationals 2022-2025 will have to show relevant documents as proof.
- Athletes who have protested against them in the 13th Junior and Sub-Junior National Para Athletics Championship should attend the classification without fail.

Registration of Athletes:

As per the current policy of PCI, every athlete must have a National license/ID card for their participation. All participants, including escorts and coaches, should apply for an ID card by depositing Rs. 1000/- to the Paralympic Committee of India's Bank Account (Details as under):

(The Proof of payment is to be submitted by the state associations for issuance of the Registration Card)

The entry and license fees of the athletes should be paid by the state associations to the Paralympic Committee of India only. It is advised for the Athletes to have a passport to apply for the International License.

Failure to Participate - If an athlete fails to participate in the first event after sending/confirming the entry without any valid reason, he/she then may not be allowed to participate in any of the remaining events entered as per the IPC rules (WPA Rule).

Call Room - All Participating Para Athletes are required to report at the Call Room, One Hour before the Scheduled Time of the Event. Any athlete reporting directly at the Competition Area will not be allowed to participate.

Equipment & Rules - IAAF (World Athletics)/IPC (WPA Rule)/PCI-approved equipment will only be used during the Championships. The 14th Junior and Sub-Junior National Para Athletics Championship shall be conducted following the current IPC Rules, (WPA Rules)/guidelines. The decision of the referee/Judges shall be final and binding for all the Para Athletes.

Protest - During the period of the championship, the designated **team manager** can raise a protest. The protest should be raised within the stipulated time (within 30 minutes), it should be submitted in writing along with a fee of Rs. 2000/-.
