Para Sports Association) is organizing the 1st U.P State Para Shooting Championship, 2025 in Rifle /Pistol will be held at Bareilly Shooting Club, from 31st January to 2nd February 2025 as per rules and regulations under STC Shooting - PCI Match Book. Entries with normal fees will be accepted till 25th January 2025 by 07:00 PM. late entries with triple entry fee will be accepted till 27th January 2025 by 09:00 PM.

Shooters, who wish to participate in this competition, are requested to go through the following instructions carefully for their own convenience and to ensure smooth and successful conduct of the above competition.

A. GENERAL TERMS & CONDITIONS, PARTICIPATION, ENTRY FEES & ENTRY FORM

- 1) All participants are requested to go through the above instructions carefully & ensure strict compliance.
- 2) All participants are expected to abide by the rules and regulations of the competition. Discipline on & off the field is very essential.
- 3) The Entry Fee by the shooter once deposited will not refunded.
- 4) The tentative program is attached herewith in **Annexure "A"**.
- 5) The Details of the entry fee are attached in **Annexure "B"**.
- 6) The Entry Form is attached in **Annexure "C"**.
- 7) **Entries will only be accepted by the respective State Para Sports Association. Shooters are requested to visit the website www.upparasports.in/events to download the entry form. Shooter needs to fill up all details, Scan the entry form along with the required documents & send it to the email ID upparashootingchampionship@gmail.com of the respective district Para Sports Association and CC to pcup.pci@gmail.com.**
- 8) All shooters must submit a Declaration by their coaches to participate in the respective events along with the filled entry form. Declaration by coach is attached in **Annexure "D"**.
- 9) **Entry with the normal fee will be accepted till the 25th January 2025 by 07:00 PM. late entries with a triple entry fee will be accepted till the 27th January 2025 by 09:00 PM by the respective State Para Sports Association.**
- 10) Shooters will have to make their own arrangements for arms & ammunition.

- 11) **Only 01 person/coach is permitted to enter the shooting range with the shooter, whereas a wheelchair-bound shooter can have 01 escort in addition to 01 person/coach accompanying him/her.**
- 12) Shooters must have valid Medical Classification card to Participate in this competition.
- 13) Entry form once submitted will not be canceled & shooters will have to pay the entry fee even if they do not come & participate in the competition. Shooters who do not pay their entry fee after the submission of the entry form will be debarred & will not be allowed to participate in any competitions for the next 02 year.
- 14) The Organizing committee is having the right to close any match or event in case of any emergency or otherwise without assigning any reason for such an action on their part.
- 15) The Organizing Committee reserves the right to amend the rules at any time at its sole discretion for events/circumstances beyond its control. Any decision made by the Organizing Committee in any such matter will be final. All participants are expected to abide by the rules and regulations for the competitions. Discipline on & off the field is very essential. Shooting practice in hotels is strictly prohibited.

B. AWARD OF MEDALS:

The medals will be awarded in individual events are as follows:

- ❖ 4 Shooters – 3 Medals
- ❖ 3 Shooters – 2 Medals
- ❖ 2 Shooters – 1 Medal
- ❖ 1 Shooter – No Medal

C. PROTEST & APPEALS:

The Protests & appeals will be dealt with as per ISSF & IPC Rules. The Protest fee is Rs. 1000/- & in case of appeal to the Jury of Appeal, the protest fee is Rs. 2000/-.

All Shooters, while submitting the entries, must attach a photocopy of their Valid Passport or Photo Identity Card (Aadhaar Card, Arms License, Driving License, etc.) Valid IPC License / PCI Medical Classification Card and Transaction Receipt.

D. DISCIPLINE:

- 1) **U.P. Para Shooting expects the highest order of discipline from the Shooter, Coach, Escort, and Accompanying person during the matches. Indiscipline on and off the field will not be tolerated and in such cases, Shooter will be disqualified and may be debarred for 02 years to participate in any competitions.**
 - 2) **Shooters, Coaches, Escorts, and Accompanying persons are not allowed to go beyond the firing lines.**
- ★ Shooters have to declare the use of medicines if any for TUE (Therapeutic Use Exemption) as per Anti-Doping Rules & Regulations.
