5. **Entry:-** All participants are advised to send their entry by Email (pcup.pci@gmail.com) to us along with required documents in a single folder (PDF file) **latest by 28th February, 2023**. Entries received after this date, will not be considered.
- The Prescribe fee for Entry/Registration is Rs. 1000/-**
 - Important documents which are mandatory to be submitted along with the entry form: **Aadhar Card, Birth Certificate/SSLC Mark Card, Passport size Photograph, Physical Distality Certificate & Entry Fee Slip.** (Note:- All the above documents should be Self Attested)
 - Athletes who meet the Entry Standard in the State Para-Athletics Championships, as fixed by PCI (Copy enclosed) are eligible to participate.
 - Maximum of two entries in each event in single class events and three entries in each event in combined class events. No reserve entry will be permitted.
 - All the entries are to be routed through their District Units and individual athlete's entry will be also accepted.
 - An Athlete can participate in a maximum of three individual events.
 - This event will also be a selection platform for the forth coming National Championship – 2023
6. **Failure to Participate:-** If an athlete fails to participate in the first event after sending/confirming the entry without any valid reason, he/she then may not be allowed to participate in any of the remaining events entered.
7. **Transport:-** Athletes / Team Officials / Escorts will have to make their arrangements, at their own cost for local and domestic transport.
8. **Call Room:-** All Participating Para Athletes are required to report at Call Room, One Hour before the Scheduled Time of the Event. Any athlete reporting directly at the Competition Area will not be allowed to participate.
9. **Equipment:-** IAAF/IPC/PCI-approved equipment will only be used during the Championships.

- a) Strictly follow the Standard Operating Procedure (SOP) & Guidelines issued by the Ministry of Youth Affairs & Sports, Government of India for Organizing Sports Competition in the Country in a COVID-19 Situation. The wearing of Mask by each Para Athletes/Team Official and also maintaining the sufficient Physical Distance will be compulsory failing a strict disciplinary action shall be taken including Disqualification from the Competition.
- b) During the period of the championship an athlete can raise a protest. The protest should be raised within the stipulated time (within 30 minutes) and it should be submitted in writing along with a fee of Rs. 1000/-.
